Note: * As per the report received from the unit concerned, the executive at Sl. No. 42, 43, 45, 51, 62 and 63 have cleared Mandatory Training beyond stipulated period of two years for earlier up-gradation (E2-E3), hence 2nd increment may be granted notionally & on actual basis from the date of passing of mandatory training. Over payment, if any, may be Recovered.

The pay up-gradation of the Executives will be under the following terms and conditions.

There will be no change in the substantive status, designation, duties and responsibilities of the Executives unless any change is ordered in any specific context.

Before fixation of pay in the upgraded scale the controlling authorities/DDO will verify the five years residency period in substantive IDA Pay Scale afresh from their respective service book.

The Time Bound up-gradation of IDA pay scale of the Executives under the policy is personal to the executive concerned. So no claim whatsoever can be made by comparison on grounds of Seniority, Class, Community, Cadre, Stream etc. Further except as provided in instant guidelines no claim will be on account of any of the other provisions of FR, SR at the context of pay scales, pay fixation, substantive status etc.



Any up-gradation due to the Executive on or before 01.10.2004 based on the earlier time bound policies; such up-gradation will be granted on the basis of options as one time relaxation if he/she is willing for such promotion and adjudged fit in accordance with concerned regulatory conditions. OPTIONS ONCE EXERCISED SHALL BE FINAL. The subsequent eligibility for IDA Pay scale up-gradation of such executives will be governed by BSNL's Time Bound Up-gradation Scheme as provided in Para (1) (b) (3.2) of BSNL's order under reference.

The Executives whose pay is upgraded to next higher IDA Pay Scale will have to compulsory undergo mandatory online up-gradation training as prescribed for being eligible for drawal of 2nd increment in the upgraded IDA Scale within a period of 2 (Two) years from the date of issuance of time bound up-gradation order. The executive who fails to successfully complete the online up-gradation training will not be eligible for consideration of next IDA scale up-gradation even if he/she is due for up-gradation otherwise.

If any disciplinary/vigilance case is pending/contemplated or punishment if any is current against any of the executives who have been placed in the upgraded IDA scale, the same may be intimated to this office before implementation of this order for the particular Executive and no up-gradation may be granted without further instructions from this office.


Further if any omission/commission is found same may be intimated to this office for rectification.
